

# Terms and Conditions for the BIG Summer Read

## **Background**

The BIG Summer Read competition (**Competition**) is an annual statewide reading challenge that is developed by Public Libraries Victoria ('**PLV**') for libraries across Victoria and is promoted by Glen Eira City Council (**Council**) through Glen Eira Libraries from Sunday 1 December 2024 through to Friday 31 January 2025.

Between Sunday 1 December 2024 and Sunday 31 January 2025 (**Competition Term**), Participants will be encouraged to read and log a minimum of ten (10) books on the ReadBooks website (**ReadBooks**) to be entered into the statewide or local prize draw. Paper entries will only be eligible for the local Glen Eira prize draw.

The Competition is open to anyone aged between 0-18 years. It aims to encourage children to read for pleasure and addresses the 'summer slide'. This refers to the loss of literacy experienced over the long summer break if children are not exposed to books or reading.

#### What participation involves:

- 1) Participation in the Competition is deemed acceptance of these Terms and Conditions.
- 2) Participants can download the Readbooks website
- 3) Participants must read and log a minimum of 10 (ten) books on ReadBooks to be eligible for entry into the Satewide and Local prize draws.
- 4) All entries must be submitted online to ReadBooks within the Competition Term
- 5) A paper form reading log will also be available from Sunday 1 December 2024 at any Glen Eira Library branch. The paper form reading log can be filled in for fun, but only participants who complete the challenge online on ReadBooks will be entered into the statewide prize draw. Paper log entries will only be eligible for the local Glen Eira prize draw.
- 6) No late entries will be accepted.

## **Eligibility**

- 7) The competition is open to participants aged 0-18 years who are members of Glen Eira Libraries or live in the City of Glen Eira.
- 8) Participants must live in Victoria.
- 9) Participants must have their parent or legal guardian's consent to enter the competition.
- 10) Children under 13 will need their parent or guardian's permission to register with ReadBooks.

- 11) To be eligible for both the statewide and local prize draw, Participants must be registered through the ReadBooks account and must choose Glen Eira Libraries as their primary library.
- 12) To be eligible for the local prize only, Participants must be registered through the ReadBooks account and must choose Glen Eira Libraries as their primary library, or submit a paper log.
- 13) Limit of one major prize per winner of the prize draw.
- 14) Glen Eira City Council employees, Councillors, and their immediate families are not eligible to enter the Competition. Immediate family includes a spouse or former spouse, de facto partner or former de facto partner, child, parent, grandparent, grandchild or sibling of an employee or a child, parent, grandparent, grandchild or sibling of an employee's spouse or de facto partner. It includes step-relations (for example, step-parents and step-children) and adoptive relations.
- 15) Limit of one major prize per winner of both the statewide and local prize draws.

## **The Competition Term**

- 16) Competition opens **Sunday 1 December 2024, at 9 am** (AEDST).
- 17) The competition closes Friday 31 January 2025, at 5 pm (AEDST).
- 18) Online entries need to be submitted by 5 pm (AEDT) on Friday 31 January 2025.
  No late entries will be accepted.
- 19) Paper log entries need to be returned to any Glen Eira Libraries branch no later than **5 pm** (AEDT) on **Friday 31 January 2025**. No late entries will be accepted.
- 20) A statewide winner will be selected at random by PLV from all eligible Victorian ReadBooks online entries on **Wednesday 19 February 2025**.
- 21) Local prize winners will be selected at random by Glen Eira Libraries from all eligible ReadBooks and paper log entries at Glen Eira Town Hall on **Monday 24 February**2025, 10am AEDST
- 22) All winners will be notified by email by Glen Eira Libraries on or before **Thursday 27 February 2025**.

#### **Prizes and Selection**

- 23) Participants who read at least ten (10) books and log them on ReadBooks or via a submitted paper log will be entered into the local prize draw.
- 24) In addition to a randomly drawn statewide prize, there will be nine local Glen Eira Library provided prizes drawn across the following age categories. These are:

#### Ages 0-5

- 1. 1 x book pack
- 2. 1 x book pack
- 3. 1 x book pack

#### Ages 6-10

- 4. 1 x Luna Park Family Pass
- 5. 1 x \$50 Lego Voucher

### Ages 11-14

- 6. 1 x Nintendo Switch
- 7. 1 x \$50 Lego Voucher

## Ages 15-18

- 1. 1 x VE Meta Headset
- 2. 1 x JBL Portable Speaker
- 25) Prizes cannot be exchanged for cash, transferred, or otherwise exchanged. Once collected, the prize becomes the property and responsibility of the respective winners. Council's decision is final, and no further correspondence will be entered into.
- 26) Winners must collect their prize from a Glen Eira Libraries branch.
- 27) Winners must be able to produce their winning entry email notification or their Library membership card when collecting the prize.
- 28) Should a prize remain unclaimed after 28 days from the date the winner was notified under clause 18, or should the winner not wish or not be able to accept the prize, a new winner will be re-drawn.
- 29) Council accepts no responsibility for lost prizes.

#### General

- 30) Participants acknowledge and agree that the Competition, is developed by PLV in accordance with their terms and conditions.
- 31) The winners' first names will be published on the Glen Eira Libraries Facebook page, Instagram page, e-newsletter and website (<u>library.gleneira.vic.gov.au</u>). By consenting to a child entering the Competition, a parent or guardian permits their child's first name to be displayed in this manner.
- 32) Council is not liable for late, lost, incomplete, invalid, incorrectly submitted, illegible, corrupted or misdirected entries, claims or correspondence concerning the Competition.
- 33) Council is not liable for any loss (including but not limited to any damage, claim,

- injury, cost or expense) suffered or incurred by any person in connection with or arising from the Competition or redemption or use of a prize.
- 34) Council reserves the right to alter or amend these terms and conditions at any time without further recourse to the Participants.
- 35) Council may require a Participant to provide proof to the satisfaction of Council of:
  - a. parental or guardian's consent to enter the Competition; and
  - b. proof that they live in Glen Eira; and
  - c. proof that they are a Glen Eira Libraries member; and
  - d. proof of age.
- 36) Council may determine not to conduct the Competition at its sole discretion. If, for any reason, any aspect of the Competition is not capable of running as planned, including because of tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of Council, Council may, in its absolute discretion, cancel, terminate, modify or suspend the Competition or invalidate any affected entries.
- 37) Council will ensure compliance with the relevant laws and standards in promoting the Competition.

## **Privacy Information**

The BIG Summer Read Challenge is a program developed by Public Libraries Victoria. The program uses ReadBooks.

ReadBooks is committed to keeping your personal information secure and only using it for the purpose you would expect. In order to perform this, they will:

- Only collect the minimum amount of data required to perform a task
- Minimise the access of your information only to those who require it within our organisation
- Not disclose or share the stored information for any purpose other than:
  - where required to perform the task for which the information was originally submitted
  - o where required to by law
- Not sell your information for any reason or use it to generate a profit
- Remove any or all personal information upon request of the person whose data has been captured
- Not retain any data that is no longer being used for the original purpose it was submitted

Please note that Glen Eira City Council and Glen Eira Libraries are not responsible for any unauthorised access or use of personal information held by ReadBooks.
